- 1. Called Board Meeting to Order. Meeting called to order at 7:25pm by Chairman Fran Wranosky. Present: Clerk Julie Belongia, Treasurer Cindy Smith, Supervisor Leonard Wahl, and Supervisor Ron Korzeniewski. Pledge of Allegiance was recited.
- 2. Approval of Agenda: Motion made by Ron /2nd by Leonard to approve the agenda as printed. All in favor. M/C.
