

TOWN BOARD MINUTES
Monday, September 12, 2022
TOWN OF MORGAN

1. **Called Board Meeting to Order.** Meeting called to order at 7:00 pm by Chairman Rob Berg.
2. **Present:** Clerk- Erin Mooers, Treasurer- Mary Jo Koslowski, Supervisor- Ron Korzeniewski, and Supervisor- Jeff Folts. **Pledge of Allegiance was recited.**
3. **Approval of Agenda:** Motion made by Jeff /2nd by Ron to approve the agenda as printed. All in favor. M/C.
 - a. A recommendation from the floor was made to amend the “next meeting date” prior to the adjournment label on the agenda.
4. **Approved Minutes of August 8, 2022, board meeting.** Motion made by Jeff/2nd by Ron to dispense with the reading of the August 08, 2022 minutes and approve as printed. All in favor. M/C.
5. **Treasurer’s Report:** Treasurer reported August deposits \$64,838.93 with beginning balance of \$346,640.45. July payouts totaled \$17,504.09. The ending balance is \$329,136.36. No motion needed for an informational report.
6. **Gillett School District- Questions and Facts about the Referendum- Todd Hencsik & Ron Lenz speakers.**

 - b. Asking for \$600k per year for the next 3 school years.
 - c. Hoping to be able to continue services, programs & small class sizes they provide.
 - d. Current funding come from state aid, which does not take current inflation into consideration causing a gap.
 - e. Mill rate will not be raised any higher than 20-21 school year.
 - f. Will only take what they need from the referendum. Previously referendum they were granted \$600k, but only took \$450k as what was needed.

 - a. **Fiber Optics-** coming to the area.
 - b. **National Estuary Research Reserve (NERR)-** University of Green Bay is looking at putting a laboratory study in for Renard Island in Green Bay.
 - a) County is requesting the lab to be in Oconto County.
 - c. **Perfluoroalkyl and polyfluoroalkyl (PFAS)-** Through the EPA PFAS is now recognized as a toxin.
 - d. **Grants-** Dave is working on a webinar training for the public on the anatomy of a grant.
 - e. **ATV/ UTV Trails-** Stiles is working on opening both sides of the high way, and an iron bridge path.
 - f. **Health & Human Service** board is collaborating with law enforcement on growing drug issues in Oconto County. Open to ideas & suggestions if anyone is interested in reaching out to them.


b. Motion made Motion made by Jeff to pay the bills as read, second by Ron. M/C.


16. Adjourn: Next meeting Monday, October 10th. Chairman Rob adjourned meeting at 7:58 PM.
